Important Questions	Answers	Why This Matters:
What is the overall <a href="#">Deductible</a> ?	For <a href="#">In-Network Provider</a> \$3,000 family. For <a href="#">Out-of-Network Provider</a> /\$6,000 family.	Generally, you must pay all of the costs from <a href="#">Providers</a> up to the <a href="#">Deductible</a> amount before this <a href="#">Plan</a> begins to pay. If you have other family members on the policy, the overall family <a href="#">Deductible</a> must be met before the <a href="#">Plan</a> begins to pay.
Are there services covered before you meet your <a href="#">Deductible</a> ?	Yes. Services that require <a href="#">Copays</a> , immunizations and <a href="#">In-Network Preventive Care</a> are covered before you meet your <a href="#">Deductible</a> .	This <a href="#">Plan</a> covers some items and services even if you haven't yet met the <a href="#">Deductible</a> amount. But a <a href="#">Copayment</a> or <a href="#">Cost Sharing</a> may apply.
